For the Paper to be published by HFES, this form must be signed by all Authors, who agree that:

- 1. All contributions to the Paper are the Author's own original work.

3. Each Author will have the following rights:
(a) All other contributed proprietary rights, including patent rights, that may be embodied in the Paper.
(b) Right to reproduce the Paper for limited internal distribution or for other personal use if (i) HFES and its publication are credited as the source of the Paper, (ii) the Paper is not used in a way that implies HFES endorsement of a product or service, and (iii) the Paper is not sold.
